

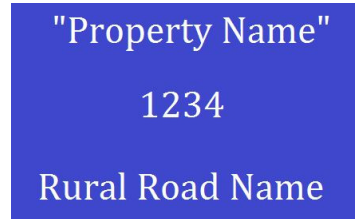
## Rural Address Sign Application Form

The address sign will be double sided, reflective blue with white writing indicating your road number, road name and property name if applicable.

Cost per sign is \$300 (GST Inc), including installation, and is payable upon application.
