

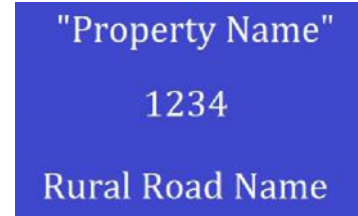
Rural Road Address Sign Application Form

(If you have more than one property, please complete a separate form for each property)

Rural road address signs are available for rural ratepayers to order and purchase.

The address sign is double sided, reflective blue with white writing indicating your road number, road name and property name if applicable.

Cost per sign (*Fees & Charges 2023/24*) is **\$371** (GST Inc), including installation, and is payable upon application.
